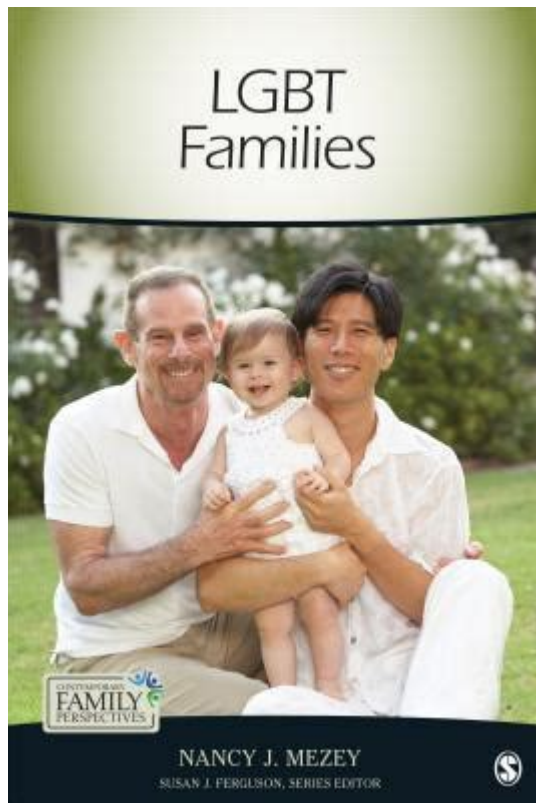


Lgbt Families Nancy J Mezey

3. PARENTS, FAMILIES, AND FRIENDS OF LESBIANS AND GAYS (PFLAG): PROVIDES SUPPORT FOR FAMILIES AND ALLIES OF LGBTQ INDIVIDUALS.

ONLINE RESOURCES AND NETWORKS
