Determine What Issues are Involved - correct answer.determine which ethical, legal, and clinical issues need to be addressed in order to resolve the dilemma

Consult Guidelines - correct answer.review ethical standards, laws, research, etc. that are relevant to the situation

Identify Alternative Solutions - correct answer.- consider what actions you've taken in similar situations in the past

- check the literature

- consult with colleagues

Consider the Consequences of Each Alternative - correct answer.consider the potential risks and benefits of each possible solution

Choose a Course of Action - correct answer.rank the alternatives in terms of positive outcomes and make a choice, preferably in conjunction with the involved parties

Scope of Practice - correct answer.the legally defined boundaries of a counselor's professional practice

CLIENT RIGHTS AND ADVOCACY

1. CLIENT AUTONOMY: RESPECTING CLIENTS' RIGHTS TO MAKE CHOICES ABOUT THEIR TREATMENT.
2. ADVOCACY: THE ROLE OF COUNSELORS IN ADVOCATING FOR CLIENTS' RIGHTS AND ACCESSING NECESSARY SERVICES.
3. GRIEVANCE PROCEDURES: UNDERSTANDING THE PROCESSES FOR ADDRESSING CLIENT GRIEVANCES AND ETHICAL VIOLATIONS.

PREPARATION STRATEGIES FOR THE EXAM

2. DISCUSSION AND DEBATE: ENGAGE IN DISCUSSIONS ON ETHICAL DILEMMAS AND LEGAL SCENARIOS TO DEEPEN UNDERSTANDING.
3. RESOURCE SHARING: SHARE STUDY MATERIALS, NOTES, AND RESOURCES WITHIN THE GROUP.
