## UNDERSTANDING MEDICAID IN LOUISIANA

## THE ROLE OF THE LOUISIANA MEDICAID ELIGIBILITY MANUAL

THE LOUISIANA MEDICAID ELIGIBILITY MANUAL IS VITAL FOR POTENTIAL APPLICANTS AND HEALTHCARE PROVIDERS. IT SERVES SEVERAL PURPOSES:

- RESOURCES: PROVIDES INFORMATION ABOUT AVAILABLE SERVICES AND BENEFITS UNDER MEDICAID.

# ELIGIBILITY CRITERIA FOR LOUISIANA MEDICAID

ELIGIBILITY FOR LOUISIANA MEDICAID IS DETERMINED BASED ON SEVERAL FACTORS, INCLUDING INCOME, HOUSEHOLD SIZE, AGE, DISABILITY STATUS, AND RESIDENCY. THE FOLLOWING SECTIONS OUTLINE THE KEY ELIGIBILITY CRITERIA.

## 1. INCOME REQUIREMENTS

INCOME ELIGIBILITY IS A CRITICAL FACTOR IN DETERMINING MEDICAID COVERAGE. LOUISIANA MEDICAID FOLLOWS THE MODIFIED ADJUSTED GROSS INCOME (MAGI) METHODOLOGY, WHICH CONSIDERS THE FAMILY'S TOTAL INCOME WHILE ACCOUNTING FOR SPECIFIC DEDUCTIONS.

- INCOME LIMITS:
- FOR MOST ADULTS, THE INCOME MUST NOT EXCEED 138% OF THE FEDERAL POVERTY LEVEL (FPL).
- CHILDREN UNDER 19 MAY QUALIFY IF THEIR FAMILY INCOME IS BELOW 247% OF THE FPL.
- PREGNANT WOMEN CAN QUALIFY AT UP TO 213% OF THE FPL.

## 2. HOUSEHOLD SIZE

THE SIZE OF THE HOUSEHOLD PLAYS A SIGNIFICANT ROLE IN DETERMINING ELIGIBILITY LIMITS. THE HOUSEHOLD IS TYPICALLY DEFINED AS:

- THE APPLICANT
- ANY OTHER INDIVIDUALS LIVING IN THE SAME RESIDENCE WHO ARE RELATED BY BLOOD, MARRIAGE, OR LAW.

## 3. AGE AND DISABILITY STATUS

DIFFERENT ELIGIBILITY CRITERIA APPLY TO VARIOUS GROUPS BASED ON AGE AND DISABILITY:

- CHILDREN: APPLICANTS UNDER 19 YEARS OLD MAY QUALIFY FOR MEDICAID OR THE CHILDREN'S HEALTH INSURANCE PROGRAM (CHIP).
- ELDERLY: INDIVIDUALS AGED 65 AND OLDER MAY QUALIFY FOR MEDICAID BASED ON INCOME AND ASSET LIMITS.
- DISABLED INDIVIDUALS: INDIVIDUALS WITH DISABILITIES MUST MEET SPECIFIC CRITERIA AND OFTEN NEED TO PROVIDE MEDICAL DOCUMENTATION TO CONFIRM THEIR STATUS.

## 4. RESIDENCY REQUIREMENTS

TO BE ELIGIBLE FOR LOUISIANA MEDICAID, APPLICANTS MUST BE RESIDENTS OF THE STATE. THIS REQUIRES PROOF OF RESIDENCE, WHICH CAN BE ESTABLISHED THROUGH:

- UTILITY BILLS
- LEASE AGREEMENTS
- OFFICIAL IDENTIFICATION

## TYPES OF MEDICAID PROGRAMS IN LOUISIANA

THE LOUISIANA MEDICAID PROGRAM ENCOMPASSES VARIOUS TYPES OF COVERAGE TAILORED TO MEET THE NEEDS OF DIFFERENT POPULATIONS. UNDERSTANDING THESE PROGRAMS HELPS APPLICANTS DETERMINE WHICH BENEFITS THEY MAY QUALIFY FOR.

## 1. TRADITIONAL MEDICAID

TRADITIONAL MEDICAID PROVIDES COMPREHENSIVE HEALTH COVERAGE FOR ELIGIBLE LOW-INCOME INDIVIDUALS AND FAMILIES. THIS PROGRAM COVERS SERVICES SUCH AS:

- HOSPITAL VISITS
- PHYSICIAN SERVICES
- PRESCRIPTION MEDICATIONS
- MENTAL HEALTH SERVICES

## 2. LOUISIANA MEDICAID EXPANSION

IN 2016, LOUISIANA EXPANDED MEDICAID UNDER THE AFFORDABLE CARE ACT, ALLOWING MORE LOW-INCOME ADULTS TO QUALIFY. THIS PROGRAM PRIMARILY SERVES:

- ADULTS AGED 19-64
- INDIVIDUALS WITH INCOMES UP TO 138% OF THE FPL
- THOSE WITH LIMITED ACCESS TO EMPLOYER-SPONSORED HEALTH INSURANCE

## 3. LACHIP (LOUISIANA CHILDREN'S HEALTH INSURANCE PROGRAM)

LACHIP PROVIDES HEALTH COVERAGE FOR UNINSURED CHILDREN IN FAMILIES WITH INCOMES TOO HIGH TO QUALIFY FOR TRADITIONAL MEDICAID. KEY FEATURES INCLUDE:

- COVERAGE FOR CHILDREN UP TO 19 YEARS OLD
- INCOME LIMITS EXTENDING UP TO 247% OF THE FPL
- COMPREHENSIVE HEALTH SERVICES, INCLUDING PREVENTIVE CARE AND DENTAL SERVICES

## 4. LONG-TERM CARE MEDICAID

LONG-TERM CARE MEDICAID ASSISTS INDIVIDUALS WHO REQUIRE ONGOING MEDICAL ASSISTANCE DUE TO AGE, ILLNESS, OR DISABILITY. THIS PROGRAM INCLUDES:

- NURSING HOME CARE
- HOME AND COMMUNITY-BASED SERVICES (HCBS)
- PERSONAL CARE ATTENDANT SERVICES

## APPLICATION PROCESS FOR LOUISIANA MEDICAID

APPLYING FOR LOUISIANA MEDICAID INVOLVES SEVERAL STEPS. UNDERSTANDING THESE STEPS CAN STREAMLINE THE PROCESS AND INCREASE THE LIKELIHOOD OF APPROVAL.

### 1. DETERMINE ELIGIBILITY

BEFORE APPLYING, POTENTIAL APPLICANTS SHOULD ASSESS THEIR ELIGIBILITY BASED ON THE CRITERIA OUTLINED IN THE LOUISIANA MEDICAID ELIGIBILITY MANUAL. UTILIZING ONLINE TOOLS OR CONSULTING WITH A HEALTHCARE NAVIGATOR CAN AID IN THIS PROCESS.

## 2. GATHER REQUIRED DOCUMENTATION

APPLICANTS MUST COLLECT VARIOUS DOCUMENTS TO SUPPORT THEIR APPLICATION, INCLUDING:

- PROOF OF INCOME (PAY STUBS, TAX RETURNS)
- IDENTIFICATION (DRIVER'S LICENSE, SOCIAL SECURITY CARD)
- RESIDENCY VERIFICATION (UTILITY BILLS, LEASE AGREEMENTS)

## 3. COMPLETE THE APPLICATION

APPLICATIONS CAN BE SUBMITTED THROUGH MULTIPLE CHANNELS:

- ONLINE: VIA THE LOUISIANA MEDICAID WEBSITE.
- BY PHONE: CONTACTING THE LOUISIANA MEDICAID CUSTOMER SERVICE CENTER.
- IN-PERSON: VISITING LOCAL MEDICAID OFFICES OR COMMUNITY ORGANIZATIONS THAT ASSIST WITH APPLICATIONS.

## 4. FOLLOW UP AND APPEAL PROCESS

AFTER SUBMITTING THE APPLICATION, APPLICANTS RECEIVE A NOTIFICATION REGARDING THEIR ELIGIBILITY. IF DENIED, INDIVIDUALS HAVE THE RIGHT TO APPEAL THE DECISION. THE APPEAL PROCESS INVOLVES:

- REVIEWING THE DENIAL NOTICE
- REQUESTING A FAIR HEARING
- PROVIDING ADDITIONAL DOCUMENTATION OR EVIDENCE IF NECESSARY
