You receive a written request from a former client for a copy of his therapy records. His request does not include your psychotherapy notes. Unless you have a lawful reason for withholding the records, you must respond to the request by sending:

- A: a copy or summary of the records within 5 days
- B: a copy or summary of the records within 15 days.
- C: a copy of the records within 7 days.
- D: a copy of the records within 15 days. - Answer-D: a copy of the records within 15 days.

HIPAA requires health providers to provide patients with copies of their records (PHI) when the provider receives a written request for the records and there is no lawful reason for withholding the records. The 15 day requirement for providing the records is established by Health and Safety Code Section 123110(b). \*Note\* HIPAA's requirements with regard to the release of a copy (rather than a summary) of records takes precedence over state law (H&SC 123110) since HIPAA is more stringent in terms of providing patients with access to their records.
