As a matter of fact, this possibility not only fulfills the second objective of retaining rights but, it also speaks to the objective of maximizing her influence. She will have the autonomy to select which ideas can be published repeatedly. Whereas with Penwright, Cordero cannot use more than a few paragraphs without obtaining approval. This fact, in itself, violates the objective of retaining rights as much as possible over future use of the book's content.
