- MONITORING PATIENTS FOR ANY ADVERSE REACTIONS OR SIDE EFFECTS
- KEEPING ACCURATE MEDICATION RECORDS
- COMMUNICATING EFFECTIVELY WITH HEALTHCARE PROFESSIONALS AND PATIENTS
- ENSURING THE PROPER STORAGE AND HANDLING OF MEDICATIONS

4. LEGAL AND ETHICAL CONSIDERATIONS

MEDICATION AIDES MUST BE AWARE OF LEGAL AND ETHICAL GUIDELINES THAT GOVERN THEIR PRACTICE. KEY POINTS INCLUDE:

- UNDERSTANDING THE SCOPE OF PRACTICE FOR MEDICATION AIDES

- CONFIDENTIALITY AND PATIENT RIGHTS
- INFORMED CONSENT
- DOCUMENTATION STANDARDS
