APPLICATION AND FEES

- The application for an Occupational Therapist license can be found by visiting http://www.michigan.gov/lara/0,4601,7,136-47417_27529_27345_00.htm. Complete all fields and answer all questions.
- Application Fee + 1 year license fee:
OT by Exam and Endorsement: \$102.70
OT Renewal: \$102.70
Must be paid by check or money order payable to the State of Michigan and submitted with completed application.

THE FOLLOWING REQUIREMENTS APPLY TO ALL APPLICANTS FOR AN OCCUPATIONAL THERAPIST LICENSE

- Criminal Background Check -- Once the application is completed and submitted you will be mailed an Application Confirmation letter containing instructions to complete the Criminal Background Check (except those applicants seeking reinstatement, if the license expired within the last three years).
- Good Moral Character Questionnaire -- Documentation and explanation will be required if you answer "yes" to either question to show at the current time you have the ability to, and are likely to, serve the public in a fair, honest, and open manner; that you are rehabilitated; or that the substance of the license offense is not reasonably related to the occupation or profession for which you are seeking a license.
- Human Trafficking -- Beginning October 15, 2020, completion of training to identify victims of human trafficking is required for initial licensure that meets the standards of Administrative Rule 308-12-15. This is a one-time training.
- Social Security Number (SSN) -- An individual applying for licensure is required to provide his or her social security number at the time of application. If exempt under law from obtaining a SSN or do not have a SSN, the SSN affidavit form will be required to be submitted with the application.
- Verification/Endorsement of Licensure -- If you hold a current license or ever held a license as an occupational therapist, verification of licensure will be required to be submitted directly to this office by the licensing agency of any state of the United States in which you held or ever held a license. Verification can be emailed to licverify@michigan.gov or mailed to Bureau of Professional Licensing, PO Box 30870, Lansing, MI 48909.
