Vacant - CORRECT ANSWER A property that has no contents, furnishings, or occupants.

Utmost Good Faith - CORRECT ANSWER The fair and equal bargaining by both parties in forming the contract, where the applicant must make full disclosure of risk to the company, and the insurance company must be fair in underwriting the risk.

Unoccupied - CORRECT ANSWER A property that has contents or furnishings in it, but is not being used or lived in.

Unintentional Tort - CORRECT ANSWER The result of acting without proper care, generally referred to as negligence.
