- IMPORTANCE OF SEAT BELTS AND SAFETY FEATURES.

5. MINNESOTA DRIVING LAWS

- SPECIFIC REGULATIONS APPLICABLE IN MINNESOTA.
- CONSEQUENCES OF VIOLATIONS (FINES, PENALTIES).

PREPARING FOR THE EXAM
