### What Is the Purpose of Form N-400?

Form N-400, Application for Naturalization, is an application to become a naturalized U.S. citizen

If your biological or legal adoptive mother or father is a U.S. citizen by birth, or was naturalized before you reached your 18th birthday, you may already be a U.S. citizen. Before you consider filing this application, please visit the U.S. Citizenship and Immigration Services (USCIS) website at <a href="https://www.uscis.gov">www.uscis.gov</a> for more information on this topic and to review the instructions for Form N-600, Application for Certificate of Citizenship, and Form N-600K, Application for Citizenship and Issuance of Certificate Under Section 322.

If either of your parents is a United States citizen, complete Part 6. Information About Your Parents as part of this application. If neither of your parents is a United States citizen, skip Part 6. and complete Part 7. Biographical Information

### A Guide to Naturalization

To help you understand the naturalization process, USCIS developed A Guide to Naturalization (M-476). This guide provides information on eligibility requirements and naturalization procedures. ### General Eligibility Requirements

You may apply for naturalization when you meet all the requirements to become a U.S. citizen. General eligibility requirements are the following:

- 1. You are at least 18 years of age at the time of filing (except active duty members of the U.S. Armed Forces);
- 2. You are a permanent resident of the United States for a required period of time
- 3. You have lived within the state or USCIS district where you claim residence for at least 3 months prior to filing;
- 4. You have demonstrated physical presence within the United States for a required period of time;
- 5. You have demonstrated continuous residence for a required period of time;
- 6. You demonstrate good moral character;
- 7. You demonstrate an attachment to the principles and ideals of the U.S. Constitution;
- You demonstrate a basic knowledge of U.S. history and government (also known as "civics") as well as an ability to read, write, speak and understand basic English; and
- 9. You take an Oath of Allegiance to the United States. Some applicants may be eligible for a modified oath

- Answer questions about your moral character, criminal history, and affiliation with organizations.
- 9. Part 9: Oath of Allegiance
- Review the oath and indicate your willingness to take it.
- 10. Part 10: Signature
- Sign and date the form to confirm that the information is accurate.

# Filing the N-400 Form

Once you have completed the N-400 form, it's time to submit it. Here are the steps to follow:

- 1. Check the Filing Fee: As of the latest guidelines, the filing fee for Form N-400 is \$725, which includes a \$640 application fee and an \$85 biometrics fee. Some applicants may qualify for a fee waiver.
- 2. Prepare Your Package: Include the completed N-400 form, required documents, and payment (check or money order).
- 3. Where to Send Your Application: The address to which you send your N-400 form depends on whether you are using the U.S. Postal Service or a courier service. Refer to the USCIS website for the correct mailing address.
- 4. Track Your Application: After submission, you can track the status of your application online using the USCIS case status tool.

## What to Expect After Filing

Once your N-400 form is submitted, you will go through several steps before receiving your citizenship:

## **Biometrics Appointment**
