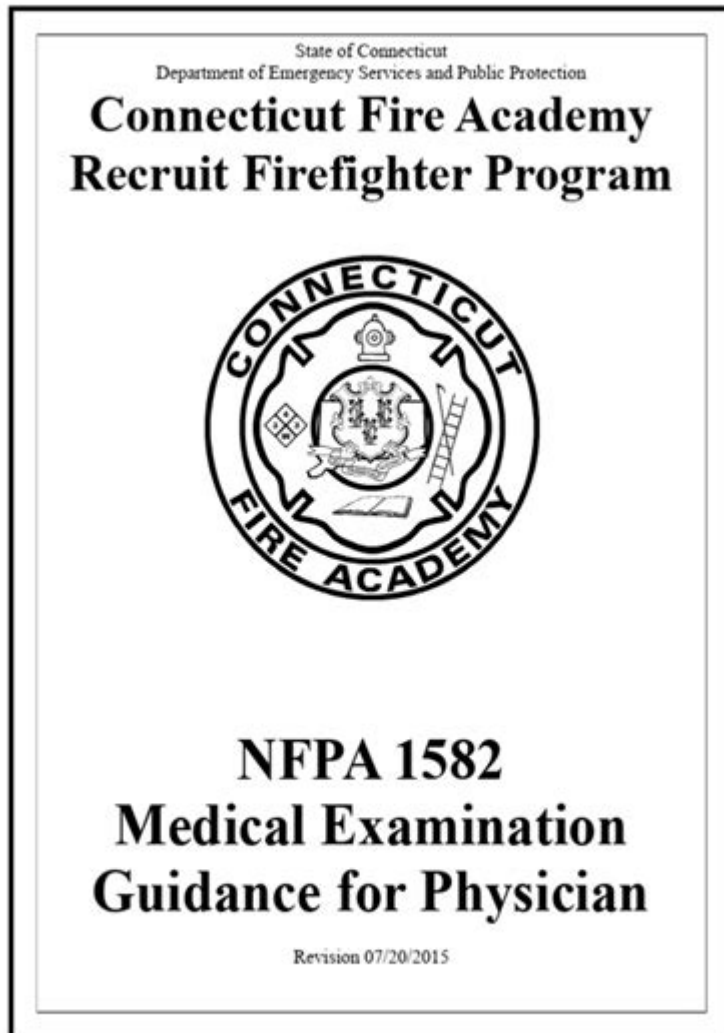


# Nfpa 1582 Medical Exam
