EXAM FORMAT

THE EXAM CONSISTS OF TWO PARTS:

1. NATIONAL PORTION: THIS SECTION COVERS GENERAL REAL ESTATE PRINCIPLES AND PRACTICES THAT ARE APPLICABLE ACROSS THE UNITED STATES.
