

# Nj Criminal History Records Check

## WHY CONDUCT A CRIMINAL HISTORY RECORDS CHECK?

THERE ARE SEVERAL REASONS INDIVIDUALS OR ORGANIZATIONS MIGHT CONDUCT A NJ CRIMINAL HISTORY RECORDS CHECK:

1. **EMPLOYMENT SCREENING:** EMPLOYERS OFTEN REQUIRE BACKGROUND CHECKS TO ENSURE THAT THEY HIRE TRUSTWORTHY CANDIDATES. CERTAIN POSITIONS, PARTICULARLY THOSE INVOLVING VULNERABLE POPULATIONS (CHILDREN, ELDERLY, ETC.), MAY REQUIRE A STRICTER REVIEW.
2. **TENANT SCREENING:** LANDLORDS MAY PERFORM BACKGROUND CHECKS TO ASSESS THE RELIABILITY AND SAFETY OF POTENTIAL TENANTS, HELPING TO MINIMIZE RISKS ASSOCIATED WITH RENTING PROPERTY.
3. **PERSONAL AWARENESS:** INDIVIDUALS MAY WISH TO CHECK THEIR OWN CRIMINAL RECORDS TO UNDERSTAND WHAT INFORMATION IS AVAILABLE AND PREPARE FOR POTENTIAL BACKGROUND CHECKS IN JOB APPLICATIONS OR OTHER SITUATIONS.
4. **LEGAL COMPLIANCE:** CERTAIN PROFESSIONS ARE MANDATED BY LAW TO CONDUCT BACKGROUND CHECKS, SUCH AS HEALTHCARE WORKERS, TEACHERS, AND LAW ENFORCEMENT OFFICERS.

## THE PROCESS OF CONDUCTING A CRIMINAL HISTORY RECORDS CHECK

CONDUCTING A NJ CRIMINAL HISTORY RECORDS CHECK INVOLVES SEVERAL STEPS, WHICH CAN VARY DEPENDING ON WHETHER YOU ARE AN INDIVIDUAL CHECKING YOUR OWN RECORD, OR IF YOU ARE AN EMPLOYER OR LANDLORD CONDUCTING A CHECK ON ANOTHER PERSON.

- FULL NAME
- DATE OF BIRTH
- SOCIAL SECURITY NUMBER (OPTIONAL BUT HELPFUL)
- CURRENT ADDRESS

## STEP 2: CHOOSE THE APPROPRIATE METHOD

IN NEW JERSEY, THERE ARE SEVERAL METHODS TO CHECK CRIMINAL HISTORY RECORDS:

1. ONLINE REQUEST: THE NEW JERSEY STATE POLICE OFFERS AN ONLINE PORTAL FOR INDIVIDUALS TO REQUEST THEIR OWN CRIMINAL HISTORY RECORDS. THIS IS A CONVENIENT OPTION FOR THOSE LOOKING TO VERIFY THEIR OWN RECORDS.
2. FINGERPRINT-BASED BACKGROUND CHECKS: FOR EMPLOYMENT OR LICENSING PURPOSES, A FINGERPRINT-BASED BACKGROUND CHECK MAY BE REQUIRED. THIS INVOLVES SUBMITTING FINGERPRINTS TO THE NJSP, WHICH WILL CONDUCT A THOROUGH BACKGROUND CHECK.
3. REQUESTING RECORDS BY MAIL: INDIVIDUALS CAN ALSO REQUEST RECORDS VIA MAIL. THIS INVOLVES COMPLETING A REQUEST FORM AND SUBMITTING IT ALONG WITH ANY REQUIRED FEES.
4. LOCAL POLICE DEPARTMENTS: IN SOME CASES, LOCAL POLICE DEPARTMENTS MAY PROVIDE ACCESS TO CRIMINAL RECORDS. CHECK WITH THE SPECIFIC DEPARTMENT FOR THEIR PROCEDURES.

## STEP 3: SUBMIT YOUR REQUEST

ONCE YOU HAVE GATHERED THE NECESSARY INFORMATION AND CHOSEN YOUR METHOD OF REQUEST, YOU WILL NEED TO SUBMIT YOUR REQUEST ALONG WITH ANY REQUIRED FEES. FOR EXAMPLE:

- ONLINE REQUESTS: FEES ARE TYPICALLY PAID VIA CREDIT CARD.
- MAIL REQUESTS: INCLUDE A CHECK OR MONEY ORDER MADE OUT TO THE NEW JERSEY STATE POLICE.

## STEP 4: AWAIT PROCESSING

PROCESSING TIMES CAN VARY. ONLINE REQUESTS MAY BE PROCESSED MORE QUICKLY THAN MAIL REQUESTS. IT IS ESSENTIAL TO BE PATIENT, AS PROCESSING TIMES CAN TAKE SEVERAL DAYS OR EVEN WEEKS, DEPENDING ON THE VOLUME OF REQUESTS.

## COSTS ASSOCIATED WITH CRIMINAL HISTORY RECORDS CHECKS

CONDUCTING A NJ CRIMINAL HISTORY RECORDS CHECK OFTEN INVOLVES ASSOCIATED COSTS. HERE ARE SOME COMMON FEES YOU MIGHT ENCOUNTER:

- SELF-REQUEST: GENERALLY, THERE IS A FEE (AROUND \$25) FOR INDIVIDUALS REQUESTING THEIR OWN CRIMINAL HISTORY RECORDS ONLINE.
- FINGERPRINT-BASED CHECKS: THESE CHECKS CAN COST SIGNIFICANTLY MORE, OFTEN RANGING FROM \$50 TO \$100, DEPENDING ON THE AGENCY CONDUCTING THE CHECK.
- EMPLOYER BACKGROUND CHECKS: EMPLOYERS MAY INCUR ADDITIONAL COSTS WHEN USING THIRD-PARTY SERVICES TO CONDUCT BACKGROUND CHECKS ON POTENTIAL HIRES.

## UNDERSTANDING WHAT THE RECORDS SHOW

ONCE THE CRIMINAL HISTORY RECORD HAS BEEN OBTAINED, IT IS ESSENTIAL TO UNDERSTAND WHAT THE INFORMATION MEANS. THE RECORDS WILL TYPICALLY INCLUDE:

- ARREST RECORDS: DETAILS ABOUT ANY ARRESTS, INCLUDING DATES AND CHARGES.
- CONVICTIONS: INFORMATION ABOUT ANY CONVICTIONS, INCLUDING THE NATURE OF THE OFFENSE AND THE SENTENCE IMPOSED.
- DISPOSITIONS: OUTCOMES OF CASES, WHETHER THEY RESULTED IN A CONVICTION, ACQUITTAL, OR DISMISSAL.
- PENDING CHARGES: ANY CHARGES THAT ARE CURRENTLY UNRESOLVED.

## IMPLICATIONS OF CRIMINAL HISTORY RECORDS CHECKS
