ELIGIBILITY REQUIREMENTS

BEFORE CANDIDATES CAN TAKE THE NJ STATE REAL ESTATE EXAM, THEY MUST MEET CERTAIN ELIGIBILITY REQUIREMENTS:

1. AGE REQUIREMENT: CANDIDATES MUST BE AT LEAST 18 YEARS OLD.
2. EDUCATION: A HIGH SCHOOL DIPLOMA OR ITS EQUIVALENT IS REQUIRED.

EXAM STRUCTURE

THE NJ STATE REAL ESTATE EXAM CONSISTS OF TWO MAIN SECTIONS: THE NATIONAL PORTION AND THE STATE-SPECIFIC PORTION.

EXAM FORMAT

- TOTAL QUESTIONS: THE EXAM COMPRISES A TOTAL OF 150 QUESTIONS.
- NATIONAL PORTION: 100 QUESTIONS COVERING GENERAL REAL ESTATE PRINCIPLES AND PRACTICES.

PREPARATION FOR THE NJ STATE REAL ESTATE EXAM

EXAM STRATEGIES

- **READ QUESTIONS CAREFULLY:** TAKE TIME TO READ EACH QUESTION AND ALL ANSWER CHOICES BEFORE MAKING A SELECTION.
- **TIME MANAGEMENT:** KEEP AN EYE ON THE TIME AND PACE YOURSELF THROUGHOUT THE EXAM.
- **REVIEW YOUR ANSWERS:** IF TIME PERMITS, REVIEW YOUR ANSWERS BEFORE SUBMITTING THE EXAM TO CATCH ANY MISTAKES.

AFTER THE EXAM

ONCE CANDIDATES HAVE COMPLETED THE NJ STATE REAL ESTATE EXAM, THEY WILL RECEIVE THEIR SCORES IMMEDIATELY. IF THEY PASS, THEY CAN PROCEED TO APPLY FOR THEIR REAL ESTATE LICENSE.

NEXT STEPS AFTER PASSING

1. **SUBMIT APPLICATION:** COMPLETE AND SUBMIT THE APPLICATION FOR A REAL ESTATE LICENSE TO THE NEW JERSEY REAL ESTATE COMMISSION.
2. **BACKGROUND CHECK:** CANDIDATES MUST UNDERGO A CRIMINAL BACKGROUND CHECK.
3. **CHOOSE A BROKERAGE:** BEFORE OBTAINING A LICENSE, CANDIDATES MUST BE AFFILIATED WITH A LICENSED NEW JERSEY REAL ESTATE BROKER.

WHAT IF YOU FAIL?

IF A CANDIDATE DOES NOT PASS THE EXAM, THEY CAN RETAKE IT. HOWEVER, THEY MUST WAIT AT LEAST 30 DAYS AFTER THEIR FIRST ATTEMPT. IT IS ESSENTIAL FOR CANDIDATES TO REVIEW THEIR PERFORMANCE AND FOCUS ON AREAS OF WEAKNESS BEFORE RETAKING THE EXAM.
