# How North Carolina Police Report Overlays Work

THE OPERATION OF POLICE REPORT OVERLAYS IS ROOTED IN DATA COLLECTION AND VISUALIZATION. HERE'S A STEP-BY-STEP BREAKDOWN OF HOW THEY FUNCTION:

## 1. DATA COLLECTION

IF YOU'RE HAVING TROUBLE FINDING THE INFORMATION ONLINE, CONSIDER REACHING OUT TO YOUR LOCAL POLICE DEPARTMENT OR SHERIFF'S OFFICE. THEY CAN PROVIDE GUIDANCE ON HOW TO ACCESS THEIR SPECIFIC OVERLAYS.

### 4. UTILIZE THIRD-PARTY PLATFORMS
