2. **HEADINGS AND SUBHEADINGS:** USE HEADINGS AND SUBHEADINGS TO BREAK DOWN YOUR ANSWER INTO SECTIONS, MAKING IT EASIER FOR THE EXAMINER TO FOLLOW YOUR REASONING.

## BE CONCISE AND PRECISE

- **AVOID OVERLY COMPLEX LANGUAGE:** USE CLEAR AND STRAIGHTFORWARD LANGUAGE. AVOID JARGON UNLESS NECESSARY, AND EXPLAIN COMPLEX TERMS IF THEY ARE USED.

- **CHECK FOR COMPLETENESS:** ENSURE THAT ALL ISSUES HAVE BEEN ADDRESSED AND THAT YOUR ANSWER FULLY RESPONDS TO THE QUESTION.
