Mr. Jackson is a 73-year-old African American. Widow of four years since his wife Mary passed away. He is visiting the Health Clinic today due to lower back pain (chief complaint). His daughter Melanie brought him to the clinic on her way to work. She is a single mother of four children (ages 5, 7, 10, 14) and is Mr. Jackson's only child. Mr. Jackson retired from the U.S. Postal Service 10 years ago after 40 years of service. He attends church every Sunday when he can, which he enjoys when he has transportation.

Nurse Jones asks, "How is your appetite?" Mr. Jackson states, "I eat a light breakfast with one cup of black coffee, a big cheese sandwich for lunch, and cereal for supper unless my daughter brings my meal, which is not often lately. I can't cook. I have nausea in the evening once in a while. My bowel movements are dark and glue-like. I do have an alcoholic beverage once or twice a week, but I have stopped smoking cigarettes." He admitted to taking one Tylenol 500mg tablet at least twice a day due to back pain over the last two weeks and sleeps a lot during the day as he has problems resting in bed at night.

The back pain has increased over the last two days and has prompted his visit to the clinic. He is ambulating slowly with facial grimacing on movement, leaning in a stooped position, and has an unsteady gait. Mr. Jackson is assisted by the nurse to remove his shirt and put on a gown. Vital signs: T 99.0 (o) P 86 R 22 B/P 160/84, and Oximetry reading 92% on room air. Medical diagnoses: BPH (Benign Prostatic Hyperplasia), A Fib (Atrial Fibrillation), Constipation, Gastric Reflux, and Psoriasis. Current Medications: Flomax 0.4 mg po daily, Colace 100 mg p.o. twice daily, Multivitamin 1 tablet po daily, Omeprazole 20 mg p.o. daily and Warfarin 5 mg p.o. daily.

Nurse Jones states, "Now, what about those glasses, Mr. Jackson? You usually wear them when you are here. I am aware by your records that you have Cataracts. Did you have the surgery three months ago as scheduled to remove them?" Mr. Jackson stated, "No. I didn't trust that doctor. I see well enough for an old man my age with possibly only a few years left in my life. Oh, do you see these bruises on my arms? Where are they coming from? My skin is so dry and itchy." I just do not want to live in a nursing home!"
