

Nurse Practice Act Indiana

 - ADMINISTERING PRESCRIBED MEDICATIONS
 - SUPPORTING PATIENT HYGIENE AND COMFORT

LICENSURE REQUIREMENTS

TO PRACTICE NURSING IN INDIANA, INDIVIDUALS MUST MEET SPECIFIC LICENSURE REQUIREMENTS, WHICH INCLUDE:

1. EDUCATIONAL QUALIFICATIONS: COMPLETION OF AN ACCREDITED NURSING PROGRAM (EITHER AN ADN OR BSN FOR RNS, AND A PRACTICAL NURSING PROGRAM FOR LPNS).
2. NATIONAL LICENSURE EXAMINATION: SUCCESSFUL COMPLETION OF THE NCLEX-RN FOR RNS OR THE NCLEX-PN FOR LPNS.
3. BACKGROUND CHECKS: SUBMISSION TO A CRIMINAL BACKGROUND CHECK AS PART OF THE APPLICATION PROCESS.
4. CONTINUING EDUCATION: PARTICIPATION IN CONTINUING EDUCATION TO MAINTAIN LICENSURE, ENSURING THAT NURSES STAY CURRENT WITH BEST PRACTICES AND ADVANCEMENTS IN HEALTHCARE.

DISCIPLINARY ACTIONS AND VIOLATIONS

THE NURSE PRACTICE ACT OUTLINES VARIOUS DISCIPLINARY ACTIONS FOR NURSES WHO VIOLATE ITS PROVISIONS. POTENTIAL VIOLATIONS MAY INCLUDE:
