

Oasis Assessment Cheat Sheet 2021

OASIS-D1 to OASIS-E

Important Information

OASIS-E changes are in alignment with the Improving Medicare Post-Acute Transformation (IMPACT) Act that was implemented in 2014 to standardize reporting data across post-acute providers.

The IMPACT Act has set the rules for Health and Human Services (HHS) to use Standardized Patient Assessment Data Elements (SPADEs) in several quality measures and submit those measures in a way to ensure standardization across the post-acute spectrum in an effort to standardize the way patients are cared for and information is communicated.

OASIS-E General Information

- OASIS-E now effective January 1, 2023 - The information is based on the Draft OASIS-E Update Instrument released 5/16/2022
- Based on the draft released 2/1/2022 and updated 5/16/22, with a 1/1/2023 start date - many items did not change from OASIS-D1 to OASIS-E
 - 9 items were removed or replaced and 27 items were added
 - Changes in numbering of new items—different than the traditional "M-items"
 - All items now divided into sections by letter —there are no sections for "L" or "P" and currently the last section is "Q"
 - More specific information for demographics, including language and transportation, questions for race and ethnicity
 - Medication management details for transfer and discharge, including how information was communicated
 - High-risk drug class question with use and indication
 - New hearing, vision, and health literacy questions
 - Comprehensive mental status assessment, including Brief Interview for Mental Status (BIMS) and Patient Mood Interview, which includes PHQ-2 to PHQ-9. New question regarding social isolation.
 - Pain questions that address the effect on sleep, therapy activities, and day-to-day activities
 - Nutritional approaches question to address various types of feeding and/or special diet
