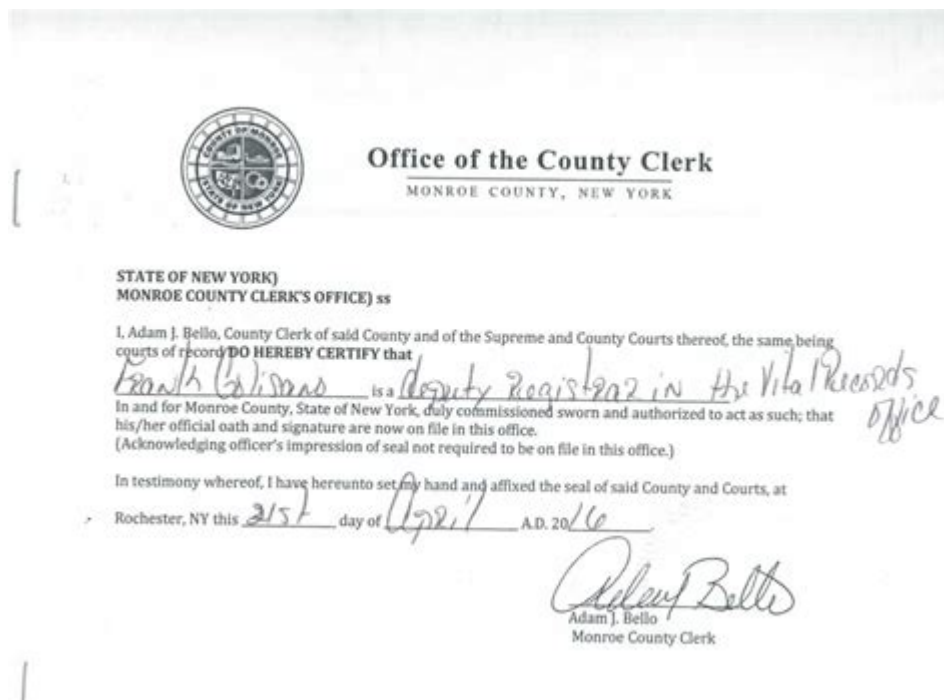


# Nys Notary Public Reference Manual
