

Politeness Strategies Brown And Levinson

POSITIVE POLITENESS STRATEGIES:

1. Notice, attend to H (his interest, wants, needs, and goods).
2. Exaggerate (interest, approval, sympathy with H)
3. Intensify interest to H.
4. Use in-group identity markers (address form, use of in group language or dialect, use of jargon or slang, contraction and ellipsis).
5. Seek agreement (safe topics, repetition)
6. Avoid disagreement (token agreement, pseudo-agreement, white lies, hedging opinions)
7. Presuppose/raise/assert common ground.

Example: "It's getting a bit chilly in here."

In this case, the speaker is not directly requesting that the window be closed. Instead, they are hinting at the desire for the window to be closed while allowing the listener to draw their own conclusion.
