


Policy Analysis Model Social Work

- **RESOURCE ALLOCATION:** POLICY ANALYSIS HELPS IN UNDERSTANDING HOW RESOURCES ARE ALLOCATED AND IDENTIFYING INEFFICIENCIES THAT CAN BE ADDRESSED TO BETTER SERVE COMMUNITIES.

KEY COMPONENTS OF POLICY ANALYSIS IN SOCIAL WORK

POLICY ANALYSIS IN SOCIAL WORK COMPRISES SEVERAL KEY COMPONENTS THAT GUIDE PRACTITIONERS IN THEIR EFFORTS TO EVALUATE AND INFLUENCE POLICIES:

4. RECOMMENDATION AND ADVOCACY
