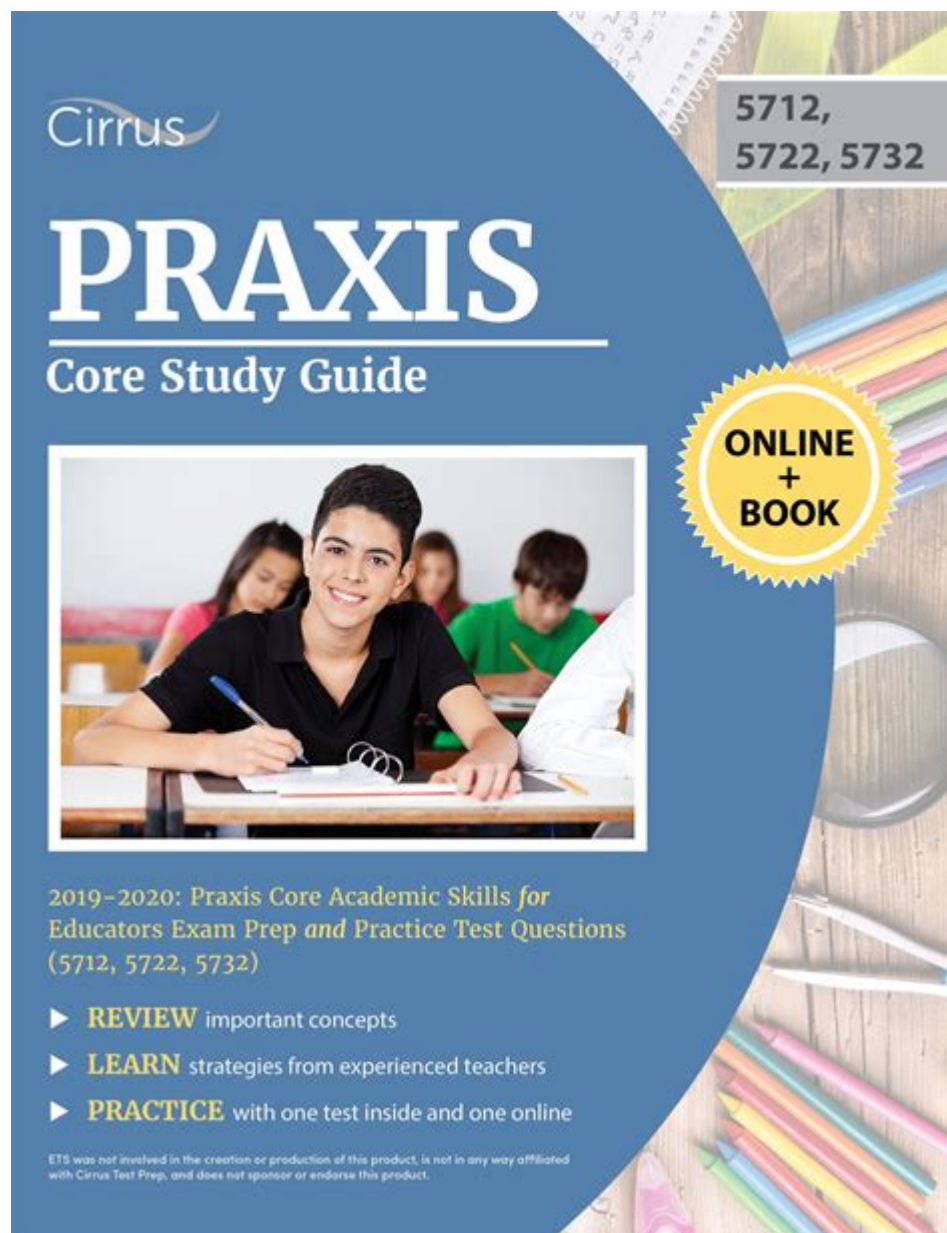

UNDERSTANDING THE PRAXIS CORE EXAM

THE PRAXIS CORE EXAM IS DIVIDED INTO THREE MAIN SECTIONS:

- **READING:** THIS SECTION EVALUATES YOUR ABILITY TO UNDERSTAND AND ANALYZE WRITTEN MATERIAL.
- **WRITING:** THIS PART TESTS YOUR COMMAND OF THE ENGLISH LANGUAGE, INCLUDING GRAMMAR, PUNCTUATION, AND

ESSAY WRITING.

- **MATHEMATICS:** THIS COMPONENT MEASURES YOUR QUANTITATIVE REASONING, ALGEBRA, AND GEOMETRY SKILLS.

EACH SECTION IS DESIGNED TO ASSESS YOUR COMPETENCY IN FUNDAMENTAL SKILLS NECESSARY FOR SUCCESS IN A TEACHER EDUCATION PROGRAM. THE EXAM IS COMMONLY REQUIRED BY MANY STATES AS PART OF THE CERTIFICATION PROCESS FOR TEACHERS.

EXAM FORMAT AND SCORING

THE PRAXIS CORE EXAM IS COMPUTER-BASED AND CONSISTS OF THE FOLLOWING:

1. READING SECTION

- NUMBER OF QUESTIONS: 56
- TIME ALLOTTED: 85 MINUTES
- SCORING RANGE: 100-200

2. WRITING SECTION

- NUMBER OF QUESTIONS: 40 (MULTIPLE-CHOICE) + 2 (ESSAY PROMPTS)
- TIME ALLOTTED: 100 MINUTES
- SCORING RANGE: 100-200

3. MATHEMATICS SECTION

- NUMBER OF QUESTIONS: 56
- TIME ALLOTTED: 85 MINUTES
- SCORING RANGE: 100-200

THE TOTAL SCORE FOR EACH SECTION IS CALCULATED BASED ON THE NUMBER OF CORRECT ANSWERS, AND SCORES ARE REPORTED TO BOTH THE TEST-TAKER AND THE INSTITUTIONS DESIGNATED BY THE TEST-TAKER.

IMPORTANCE OF THE PRAXIS CORE EXAM

PASSING THE PRAXIS CORE EXAM IS CRUCIAL FOR SEVERAL REASONS:

- **CERTIFICATION REQUIREMENT:** MOST STATES REQUIRE PASSING SCORES ON THE PRAXIS CORE AS A PREREQUISITE FOR ENTERING A TEACHER PREPARATION PROGRAM.

- GET PLENTY OF SLEEP, EAT NUTRITIOUS MEALS, AND EXERCISE REGULARLY TO MAINTAIN YOUR PHYSICAL AND MENTAL WELL-BEING.
- CONSIDER RELAXATION TECHNIQUES SUCH AS MEDITATION OR DEEP BREATHING TO REDUCE TEST ANXIETY.

THE PRAXIS CORE EXAM IS A STANDARDIZED TEST THAT ASSESSES THE BASIC SKILLS IN READING, WRITING, AND MATHEMATICS OF INDIVIDUALS WHO ARE ENTERING TEACHER EDUCATION PROGRAMS. IT IS OFTEN REQUIRED FOR ADMISSION TO THESE PROGRAMS.
