2. EAT A HEALTHY BREAKFAST: A NUTRITIOUS BREAKFAST CAN HELP MAINTAIN YOUR ENERGY LEVELS DURING THE TEST.
3. ARRIVE EARLY: ARRIVE AT THE TESTING CENTER WITH PLENTY OF TIME TO SPARE TO AVOID LAST-MINUTE STRESS.

DURING THE EXAM

- READ QUESTIONS CAREFULLY: TAKE YOUR TIME TO UNDERSTAND WHAT EACH QUESTION IS ASKING BEFORE SELECTING AN ANSWER.
- MANAGE YOUR TIME: KEEP AN EYE ON THE CLOCK TO ENSURE YOU HAVE ENOUGH TIME TO ANSWER ALL QUESTIONS.
- STAY CALM: IF YOU ENCOUNTER A DIFFICULT QUESTION, MOVE ON AND COME BACK TO IT IF TIME PERMITS.
