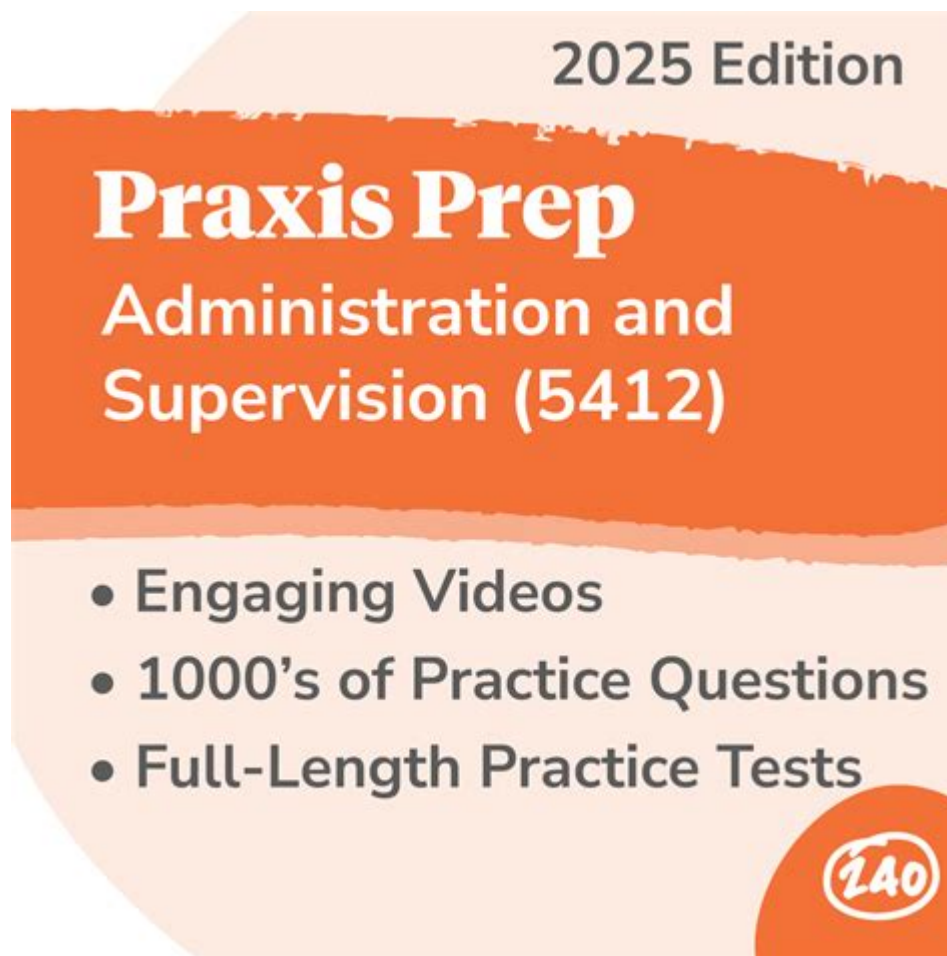

4. INSTRUCTIONAL STRATEGIES - CANDIDATES NEED TO SHOW THEIR KNOWLEDGE OF EFFECTIVE INSTRUCTIONAL STRATEGIES, INCLUDING DIFFERENTIATED INSTRUCTION, UNIVERSAL DESIGN FOR LEARNING (UDL), AND BEHAVIOR MANAGEMENT TECHNIQUES.

5. COLLABORATION AND COMMUNICATION - THIS SECTION ASSESSES CANDIDATES' ABILITY TO COLLABORATE WITH FAMILIES, OTHER PROFESSIONALS, AND EDUCATIONAL STAKEHOLDERS TO SUPPORT STUDENTS WITH DISABILITIES.

6. PROFESSIONAL AND ETHICAL PRACTICES - CANDIDATES MUST BE FAMILIAR WITH THE ETHICAL RESPONSIBILITIES AND PROFESSIONAL CONDUCT REQUIRED IN SPECIAL EDUCATION.
