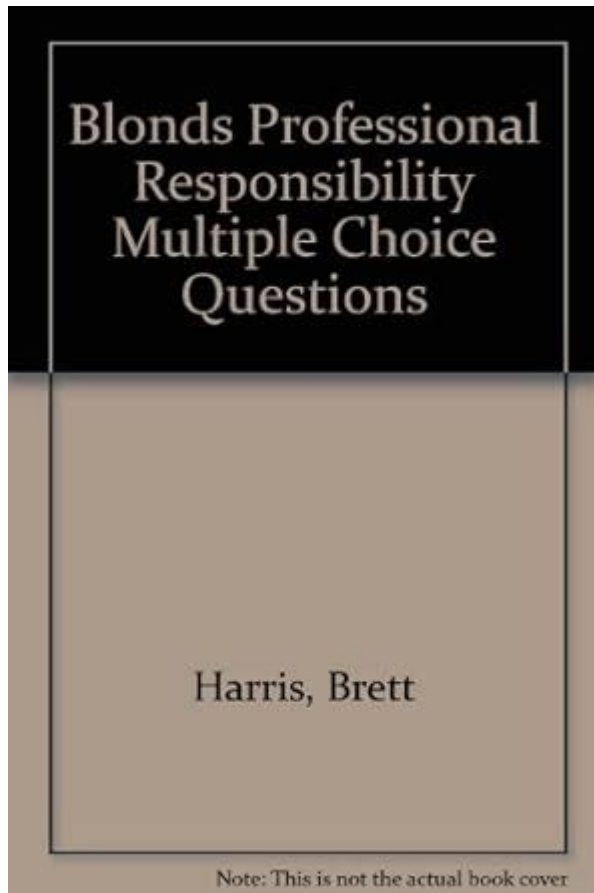


# Professional Responsibility Multiple Choice Questions
