 - Transporting goods through silk road was expensive, slow and unprofitable, Muslim Middleman collect taxes as goods were passed
 - Wanted to find a water passage to wealthy spice islands in Indonesia -> land kept secret by Muslim rulers
 - · Pushed for this route to eliminate Muslim middlemen
