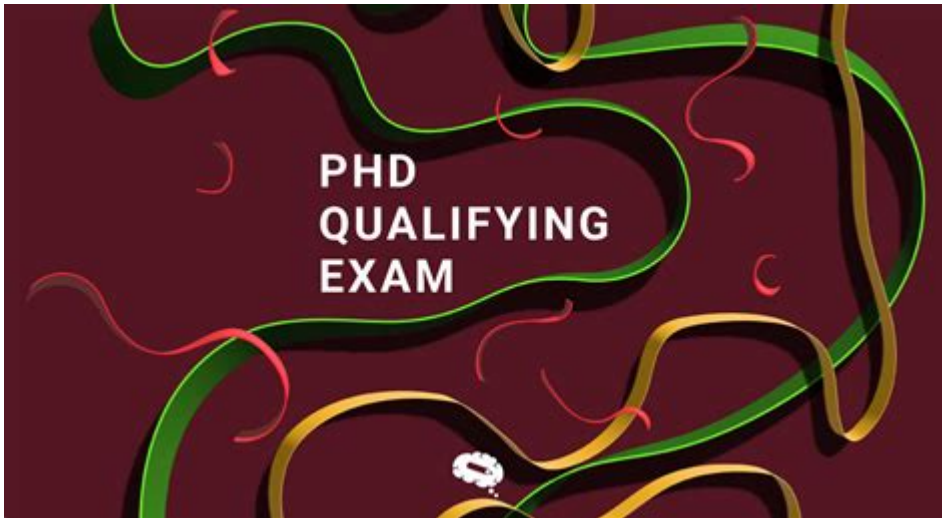


Qualifying Exams For Phd
