- Must be carried by the agent at all times when serving as a salesperson.

Fiduciary - Correct Answer-A person who on behalf of or for the benefit of another transacts business or handles money or property not the person's own; such relationship implies great confidence and trust.

OLD CAR - Correct Answer-- Obedience
- Loyalty
