How is the NAR code of ethics organized? - A preamble and 17 Articles

The first 9 Articles are "Duties to Clients and Customers,"

Articles 10 through 14 are "Duties to the Public"

Articles 15, 16, 17 are "Duties to Realtors"

When was the NAR code of ethics adopted? - 1913

What does article 1 of the NAR code of ethics state? - A realtor must put their client's interests above their own

And must use their best efforts to achieve their client's objective

While also treating all other parties involved fairly and honestly

What does article 2 of the NAR code of ethics state? - Realtors must avoid misrepresentation by disclosing all known/latent defects on a property

Realtors should not advise in areas outside their expertise (cannot be expected to discover a latent defect on their own)

Realtors should not disclose confidential facts

What is the NAR standard of practice 1-3? - Realtors shall not deliberately mislead the owner of a property as to the market value when attempting to secure a listing

What does the NAR standard of practice 1-5 require? - Written consent for intermediary relationships.

What is the NAR standard of practice 1-6? - Submitting offers & counteroffers quickly as possible

What do NAR standards of practice 1-7 and 1-8 discuss? - The realtor's submission of offers/counteroffers until closing/acceptance

What is the NAR standard of practice 1-9? - Don't reveal confidential information

What do the NAR standards of practice 1-10 and 1-11 discuss? - The realtor's obligation to competently manage/protect the property against losses
