ILLINOIS BAR EXAM TO BE HELD REMOTELY

Illinois Bar exam to be held remotely Oct. 5- 6; in-person exam set for Sept. 9-10 cancelled

The Illinois Supreme Court announced today that due to continuing public health concerns raised by the COVID-19 pandemic, the Illinois in-person bar examination scheduled for September 9-10, 2020, has been cancelled. In its place, the Illinois Board of Admissions to the Bar will offer a remote version of the exam on October 5-6, 2020, using questions prepared by the National Conference of Bar Examiners. This exam will satisfy the requirements of Illinois Supreme Court Rules 701 and 704.

The Illinois Board of Admissions to the Bar has been in close and frequent contact with the Illinois Supreme Court, monitoring the ever-evolving science and guidelines as the nation, state, and local authorities navigate this once-in-a-generation pandemic. As an independent commission of this Court, the Illinois Board of Admissions to the Bar has worked to assure the goals of public protection and a safe, secure bar exam.

The Board carefully monitored developments in Illinois. Consistent with the encouraging statistics and the Governor's reopening pursuant to the Stage IV guidelines, the Board worked to identify multiple venues that would allow for social distancing and precautions, in guidance with federal, state, and local authorities. As the statistics in Illinois over the past week have shown discouraging signs of a resurgence, however, the Board recommended to the Court that it consider a remote bar exam.

The test will cover the same topics as the in-person exam and will qualify applicants for admission in Illinois only. It will not result in a Uniform Bar Exam score. However, the Illinois Supreme Court has

- CONSTITUTIONAL LAW
- CONTRACTS
- CRIMINAL LAW AND PROCEDURE
- EVIDENCE
- REAL PROPERTY
- TORTS

2. **ILLINOIS ESSAY QUESTIONS:** CANDIDATES MUST ALSO COMPLETE SEVERAL ESSAY QUESTIONS THAT FOCUS ON ILLINOIS LAW. THESE QUESTIONS TEST THE APPLICANT'S ABILITY TO APPLY LEGAL PRINCIPLES TO SPECIFIC SCENARIOS. THE ILLINOIS BAR EXAM TYPICALLY INCLUDES:

- THREE ESSAY QUESTIONS
- A PERFORMANCE TEST THAT ASSESSES PRACTICAL SKILLS, SUCH AS DRAFTING A LEGAL DOCUMENT.

SCORING AND RESULTS

TO PASS THE ILLINOIS BAR EXAM, CANDIDATES MUST ACHIEVE A MINIMUM SCORE SET BY THE ILLINOIS BOARD OF ADMISSIONS TO THE BAR. THE MBE AND ESSAY COMPONENTS ARE WEIGHTED DIFFERENTLY IN THE FINAL SCORE CALCULATION. THE EXAM IS ADMINISTERED TWICE A YEAR, IN FEBRUARY AND JULY, AND RESULTS ARE USUALLY RELEASED APPROXIMATELY 10 WEEKS AFTER THE EXAM DATE.

THE ROLE OF REDDIT IN BAR EXAM PREPARATION

3. **r/ILLINOIS**: THIS SUBREDDIT COVERS VARIOUS TOPICS RELATED TO ILLINOIS, INCLUDING LEGAL MATTERS. CANDIDATES MAY FIND STATE-SPECIFIC ADVICE AND NETWORKING OPPORTUNITIES.

COMMON THEMES AND DISCUSSIONS

4. **TAKE CARE OF YOURSELF:** AMID THE INTENSE STUDYING, DON'T FORGET TO PRIORITIZE SELF-CARE. ENSURE YOU GET ENOUGH SLEEP, EXERCISE, AND MAINTAIN A BALANCED DIET. MENTAL HEALTH IS JUST AS IMPORTANT AS ACADEMIC PREPARATION.
5. **STAY CONNECTED:** ENGAGE WITH THE REDDIT COMMUNITY AND OTHER CANDIDATES. SHARING EXPERIENCES AND ADVICE CAN ALLEVIATE STRESS AND PROVIDE NEW INSIGHTS INTO EFFECTIVE STUDY STRATEGIES.

HOW LONG DOES IT TAKE TO RECEIVE RESULTS FROM THE ILLINOIS BAR EXAM?

RESULTS ARE USUALLY RELEASED ABOUT 10 WEEKS AFTER THE EXAM, BUT THIS TIMELINE CAN VARY.
