1	Abraham Lincoln, in 1862, freed top Union General George G. Meade. Lincoln had seen critical of Meade's passive battle field strategies and was convinced that he would not lose his Confederate counterpart, Robert E. Lee.			
2	In 1948, President Harry S. Truman issued Executive Order 9835. This executive order abolished (ended) racial discrimination in the United States Armed Forces and desegregated the troops.			
3	In July of 1969, President Richard Nixon flew to the USS Hauer in the Pacific Ocean to welcome back the crew of Apollo 11. The Apollo 11 mission sent the first man to the moon, Neil Armstrong.			
4	After winning the Presidency in 2016, Donald Trump began to pick a number of people to serve in his cabinet. For the Attorney General he picked Senator Jeff Sessions and for the Secretary of State he chose former EconModel CEO Rex Tillerson.			
5	President Richard Nixon and Soviet General Secretary Leonid Brezhnev signed the ABM Treaty and interim SALT agreement 1972, in Moscow. For the first time during the Cold War, the United States and Soviet Union had agreed to limit the number of nuclear missiles in their arsenals.			
6	By August 1945, WWII in Europe had ended, but the war against Japan was still going on. Combined a land invasion of Japan might result in the death of one million U.S. men. President Harry Truman made the decision to drop the newly created Atomic Bomb first on Hiroshima, Japan and then on Nagasaki, Japan. Each bomb would kill over 300,000, however Japan would surrender and WWII was over.			
7	In his first 100 days in office, President Roosevelt introduced many pieces of legislation aimed at bringing the United States out of the Great Depression. These laws fell into three categories: relief, reform, and recovery.			
8	After Hillary Clinton defeated Bernie Sanders in the 2016 Democratic Primary, President Barack Obama campaigned extensively for her in key battleground states.			
9	In order to stimulate the economy, President George W. Bush introduced a series of tax cuts for many Americans, but specifically for many of our highest earners in hopes that they would expand businesses and hire more workers.			
10	In 1981, Sandra Day O'Connor was appointed to the Supreme Court of the United States by Ronald Reagan. After her Senate confirmation, she became the first female to serve on our nation's highest court.
