Components	Chemical Dependency Rule 25 Assessment Services
	Rule 25 chemical health assessments for Dakota County eligible and authorized individuals to access State of Minnesota's Consolidated Chemical Dependency Treatment Fund (CCDTF).
Target Group	1. Dakota County eligible individuals presenting need or requesting CCDTF access.
Goal/Purpose	1. Assess client need for chemical health treatment and provide access to CCDTF resources. 2. Determine level of care within six dimensions, based on Rule 25 assessment. 3. Use Rule 25 to refer to appropriate treatment provider based on acuity, intensity.
Referral Process	1. The County will provide a list of qualified Rule 25 assessment contractors to clients. 2. The County will ensure client completion of eligibility application. 3. The County will provide client with an authorization number, indicating they are eligible to complete a Rule 25 assessment by selecting a Dakota County Chemical Health contractor. 4. The client must call Contractor within 30 days of authorization for authorization to be valid. 5. The Contractor will conduct a Rule 25 assessment at the Contractor's place of business, or at a location otherwise approved by the County. 6. The Contractor will complete all required releases of information with each assessment. 7. If 145 calendar days lapse between Rule 25 assessment and initiation of services, the Rule 25 must be updated to determine whether risk description has changed. Client eligibility may also require updating. In the event this occurs, Contractor will refer client back to County to determine eligibility.
Services	1. Conduct Rule 25 assessments in accordance with Minnesota Rules, 9500.0000-9500.0625. 2. Upon receiving call from client, Contractor has up to 28 days to conduct their Rule 25 assessment. 3. Submit each Rule 25 assessment and all relevant documentation within seven (7) business days to the County. If information is insufficient or incomplete, the Contractor notifies the client and completes the assessment. The County reviews the assessment and makes a treatment decision within three (3) business days. 4. Contractor shall update assessments or so cost for access that occur for any individual client within six (6) months of the original Rule 25 assessment date.
Process/Measures	1. The Contractor conducts Rule 25 assessments directly; no client may self-administer. 2. The Contractor maintains copies of all paperwork submitted to the County. 3. All required assessment documentation must be submitted for the final approval by the County, and must be complete, accurate and legible. This includes Rule 25 and releases, as well as associated releases of information forms. 4. The Contractor informs the client that the County has final placement authority for CCDTF. 5. Any assessor with continued or repeated performance issues may be prohibited from completing Rule 25 assessments on behalf of the County. 6. The Contractor must utilize professional judgment when conducting Rule 25 assessments; Contractor may not actively encourage client to receive any specific type of treatment offered at their organization. Contractor may share information after
