

Saved By The Law

CRIMINAL LAW PROTECTIONS

LANDMARK CASES: SAVED BY THE LAW

THROUGHOUT HISTORY, VARIOUS LANDMARK CASES HAVE EXEMPLIFIED HOW INDIVIDUALS HAVE BEEN "SAVED BY THE LAW." THESE CASES OFTEN SET PRECEDENTS THAT SHAPE LEGAL INTERPRETATIONS AND PROTECTIONS.

BROWN V. BOARD OF EDUCATION (1954)

ONE OF THE MOST SIGNIFICANT SUPREME COURT CASES IN AMERICAN HISTORY, BROWN V. BOARD OF EDUCATION, ADDRESSED RACIAL SEGREGATION IN PUBLIC SCHOOLS. THE COURT'S RULING DECLARED THAT "SEPARATE BUT EQUAL" EDUCATIONAL FACILITIES WERE INHERENTLY UNEQUAL, THUS VIOLATING THE EQUAL PROTECTION CLAUSE OF THE FOURTEENTH AMENDMENT. THIS DECISION WAS INSTRUMENTAL IN THE CIVIL RIGHTS MOVEMENT AND SERVED AS A CATALYST FOR FURTHER LEGAL CHALLENGES AGAINST RACIAL DISCRIMINATION.

ROE V. WADE (1973)

ROE V. WADE WAS A LANDMARK DECISION IN WHICH THE SUPREME COURT RECOGNIZED A WOMAN'S LEGAL RIGHT TO CHOOSE TO HAVE AN ABORTION UNDER THE RIGHT TO PRIVACY. THIS CASE HAS HAD LASTING IMPLICATIONS FOR WOMEN'S RIGHTS AND REPRODUCTIVE HEALTH, SIGNIFICANTLY INFLUENCING THE ONGOING DEBATE SURROUNDING ABORTION ACCESS AND WOMEN'S AUTONOMY OVER THEIR BODIES.

MIRANDA V. ARIZONA (1966)

IN MIRANDA V. ARIZONA, THE SUPREME COURT ESTABLISHED THE REQUIREMENT THAT INDIVIDUALS TAKEN INTO POLICE CUSTODY MUST BE INFORMED OF THEIR RIGHTS BEFORE BEING INTERROGATED. THIS RULING LED TO THE CREATION OF "MIRANDA RIGHTS," WHICH INCLUDE THE RIGHT TO REMAIN SILENT AND THE RIGHT TO AN ATTORNEY. THIS CASE EXEMPLIFIES HOW PROCEDURAL RIGHTS CAN PROTECT INDIVIDUALS FROM COERCIVE INTERROGATION PRACTICES.

THE BROADER IMPLICATIONS OF LEGAL PROTECTIONS
