 - INTEGRATION WITH FINANCIAL ACCOUNTING (FI) FOR FUND MANAGEMENT
 - INTEGRATION WITH PROJECT SYSTEM (PS) FOR PROJECT TRACKING
 - INTEGRATION WITH CONTROLLING (CO) FOR COST ANALYSIS

TESTING AND VALIDATION

ONCE THE CONFIGURATION IS COMPLETE, IT IS ESSENTIAL TO CONDUCT THOROUGH TESTING AND VALIDATION TO ENSURE THAT ALL SETTINGS FUNCTION AS EXPECTED.
