3. What crime is the defendant, Anna, charged with?
Is the charge a misdemeanor or a felony?

4. Why does the defendant's lawyer not want to make a plea deal (or settle) to a lesser charge?

5. What does the defendant's lawyer suggest about the role of race in the court system?

6. In Cuyahoga county, what percent of defendant's are provided a free public attorney (defendant)?

7. What is "law enforcement code" and how does this impact the defendant's chance of getting her case dismissed?

8. What reasons does the prosecutor give for her refusal to drop the "charges" against this Anna?

9. Obviously, the defense attorney and the prosecutor have a difference of opinion in this case, and a difference of opinion of what evidence the video footage provides. What is your opinion? Whom would you have sided with and why?

IMPACT OF TECHNOLOGY

COMMON QUESTIONS
