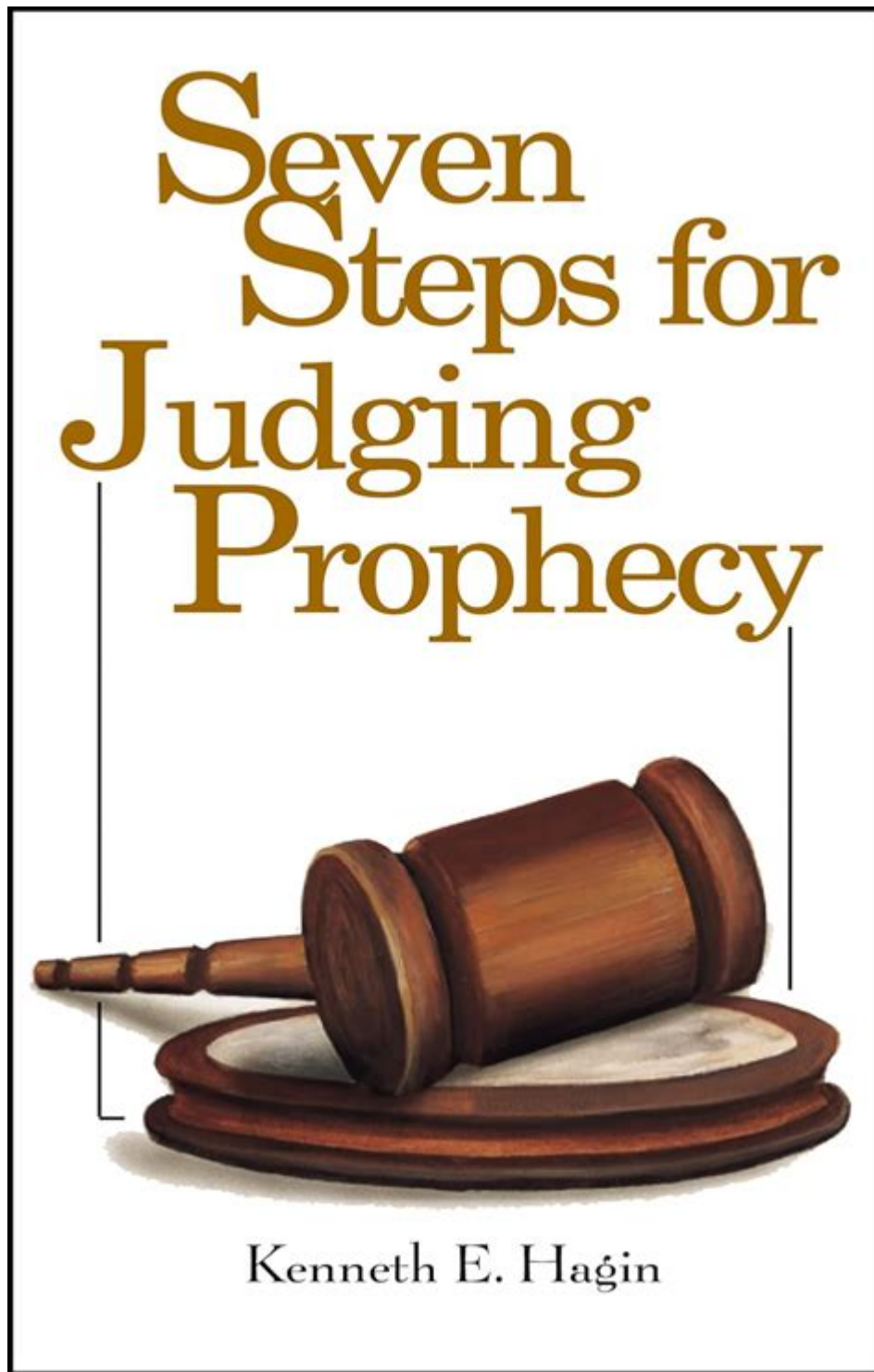


# Seven Steps For Judging Prophecy
