Ethical Dilemmas in Social Workers' Practice

Ethical dilemmas are a common occurrence in social workers' practice. The involvement of numerous stakeholders with different interests, values and goals often creates situations that demand resolution of complex decision-making processes. The current paper examines the case of Fern, a 17-year-old Chinese girl with developmental delays and a complicated health condition who requires the services of professional clinicians in order to ensure an adequate level of welfare.

Since Fern cannot make decisions, her parents have decided to terminate hospitalisation and take Fern home for cultural reasons. In order to resolve the emerging dilemma, it is necessary to identify the involved stakeholders, model two possible courses of events, evaluate the implications of each and come to a conclusion regarding the preferential option using an ethical decision-making framework.

Ethical Dilemma

A situation can be considered an ethical dilemma when several possible solutions to the problem are valid and relevant but mutually exclusive, with no evident advantage to any of them (Weber & Pockett 2011). In this case, Fern, who is both non-verbal and suffering from Proteus syndrome (a rare condition of tissue overgrowth) requires constant and exhaustive medical care that is difficult to provide at home. Her previous developmental and family history indicates benefits received from hospitalisation as well as some evidence of difficulties experienced by the parents in their attempts to provide adequate care at home.

A recent review of the child's condition identified an increasing need for hospitalisation. However, during a conference organised to update the care plan, the parents expressed a reluctance to comply with the scenario recommended by the medical experts and stated their intention to take their daughter home, citing cultural reasons. Since Fern is unable to make decisions due to developmental delays, there is an apparent conflict of interest that clearly involves her well-being and presents no obvious solution.

Social work ethical dilemmas case studies offer valuable insights into the complexities faced by professionals in the field. Social workers often navigate challenging situations that involve conflicting values, legal obligations, and the needs of clients. Confidentiality is a fundamental principle in social work; clients must feel safe to disclose sensitive information. However, when a client poses a potential threat to another individual, social workers have a legal and ethical obligation to act to prevent harm.

Resolution Steps

- 1. Assess the Risk: Lisa conducts a thorough risk assessment, asking Mark about his intentions and any specific plans he may have.
- 2. Consultation: Lisa consults with her supervisor and other professionals to discuss the best course of action while considering ethical guidelines.
- 3. Informing the Client: Lisa explains to Mark the limits of confidentiality, emphasizing her duty to protect others.
- 4. Taking Action: Lisa decides to notify the ex-partner and the authorities about Mark's threats while supporting Mark in finding healthier ways to cope with his anger.

Outcome and Reflection

This case highlights the tension between confidentiality and the duty to warn. Lisa's actions ultimately protect the ex-partner while also providing Mark with resources to manage his emotions. This case illustrates the importance of clear communication and ethical decision-making in social work practice.

Case Study 2: Cultural Competence vs. Client Autonomy

Background

Maria, a social worker, is working with a family from a cultural background that emphasizes collectivism and family decision-making. The parents wish to pursue traditional healing practices for their child's medical condition rather than conventional medical treatment. Maria finds herself in an ethical dilemma between respecting the family's cultural beliefs and ensuring the child's well-being.

The Dilemma

Cultural competence is essential in social work, but it can conflict with the responsibility to advocate for a child's health and safety. Maria must navigate this delicate situation while considering the family's values.

Resolution Steps

- 1. Cultural Understanding: Maria takes time to learn about the family's cultural beliefs and practices, aiming to understand their perspective fully.
- 2. Open Dialogue: Maria engages the family in open discussions about their choices, providing information about both traditional and conventional treatments.

- 4. Empowerment: Maria encourages the family to make informed decisions, supporting their autonomy while emphasizing the importance of the child's well-being.

Outcome and Reflection

Through respectful dialogue and collaboration, Maria finds a middle ground that respects the family's cultural values while advocating for the child's health. This case illustrates the importance of cultural competence and the need for social workers to balance respect for diversity with their ethical obligations to protect vulnerable individuals.

Case Study 3: Resource Allocation and Social Justice

Background

In a community facing significant economic hardship, social worker James is responsible for allocating limited resources among various community programs. He is approached by a program aimed at helping homeless individuals and another focused on supporting at-risk youth. Both programs present compelling needs, but resources are insufficient to fully fund both initiatives.

The Dilemma

James faces an ethical dilemma regarding resource allocation. He must consider principles of social justice and the potential impact of his decision on vulnerable populations.

Resolution Steps

- 1. Needs Assessment: James conducts a thorough needs assessment to evaluate the impact of both programs on the community.
- 2. Stakeholder Engagement: He involves community members, program leaders, and other stakeholders in discussions about resource allocation, seeking diverse perspectives.
- 3. Equity Considerations: James assesses which program will serve the most marginalized groups and align with the principles of social justice.
