Foundational Documents/Court Cases:

- -Article III of the US Constitution: Establishes the supreme court as
 - judicial power of US Says Congress can "ordain and establish" other inferior courts

-Federalist #78

- Argues how and for how long justices will be appointed and what kind of power the judicial branch should have
- Hamilton says all appointed judges shall hold offices during good behavior (life)
 - Lifetime appointments necessity to keep judicial branch as independent as branch as independent as possible
- Federal judges should have judicial review; everything unconstitutional is
 - Does not make judicial branch more powerful than legislative; the power of the people is superior
 - Balances and checks legislative branch

-Marbury v. Madison (1803)

- Background: President Adams in his iast days packed the federal decision of the court judiciary w/ federalist judges who would frustrate incoming Jefferson • Legislators can pass laws that
 - Some commissions were not delivered→ upset William Marbury

- · Marbury (judge who did not receive his commission) sued Madison and the supreme court to get his commission via a writ of mandamus (court order for an official to do what they're legally required to do) for Madison to deliver the commission
- Constitutional Principle: the jurisdiction (scope of power court exercises over different kinds of cases) clauses in Article III of the Constitution
- Decision: Marbury had the legal right to his commission, and the writ of mandamus is the correct way to get it, but the court DOES NOT have the authority to grant the writ of mandamus
 - Article III does not say anything ab the court issuing writ of mandamus
- Article 13 of Judiciary act conflicted with Article III of Constitutionarticle 13 is unconstitutional and therefore null and void
- Importance: Marshall invested Supreme Court with power of judicial review; they are the final interpreter of the Constitution
