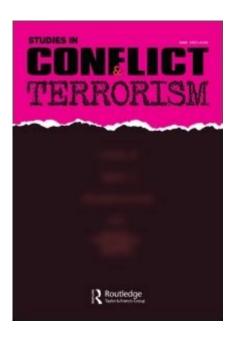
Studies In Conflict And Terrorism
