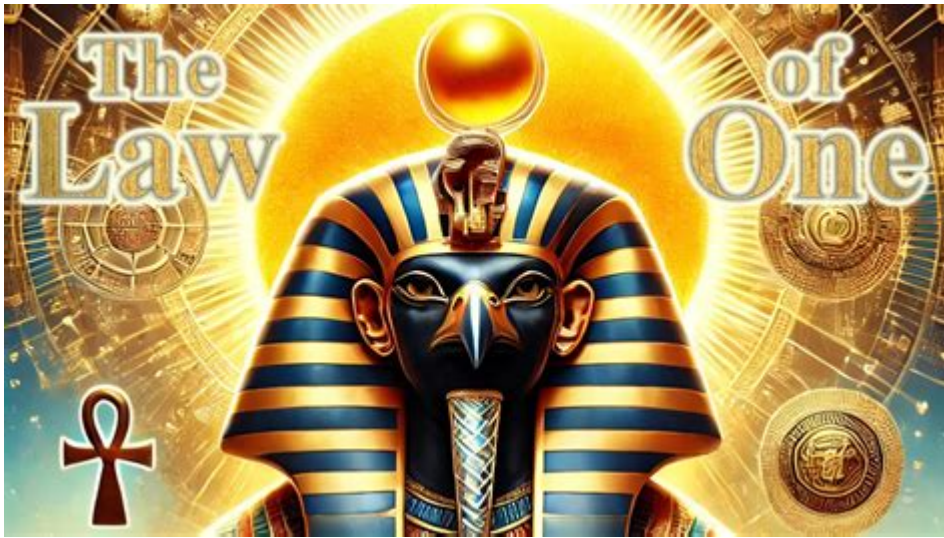


The Law Of One Ra
