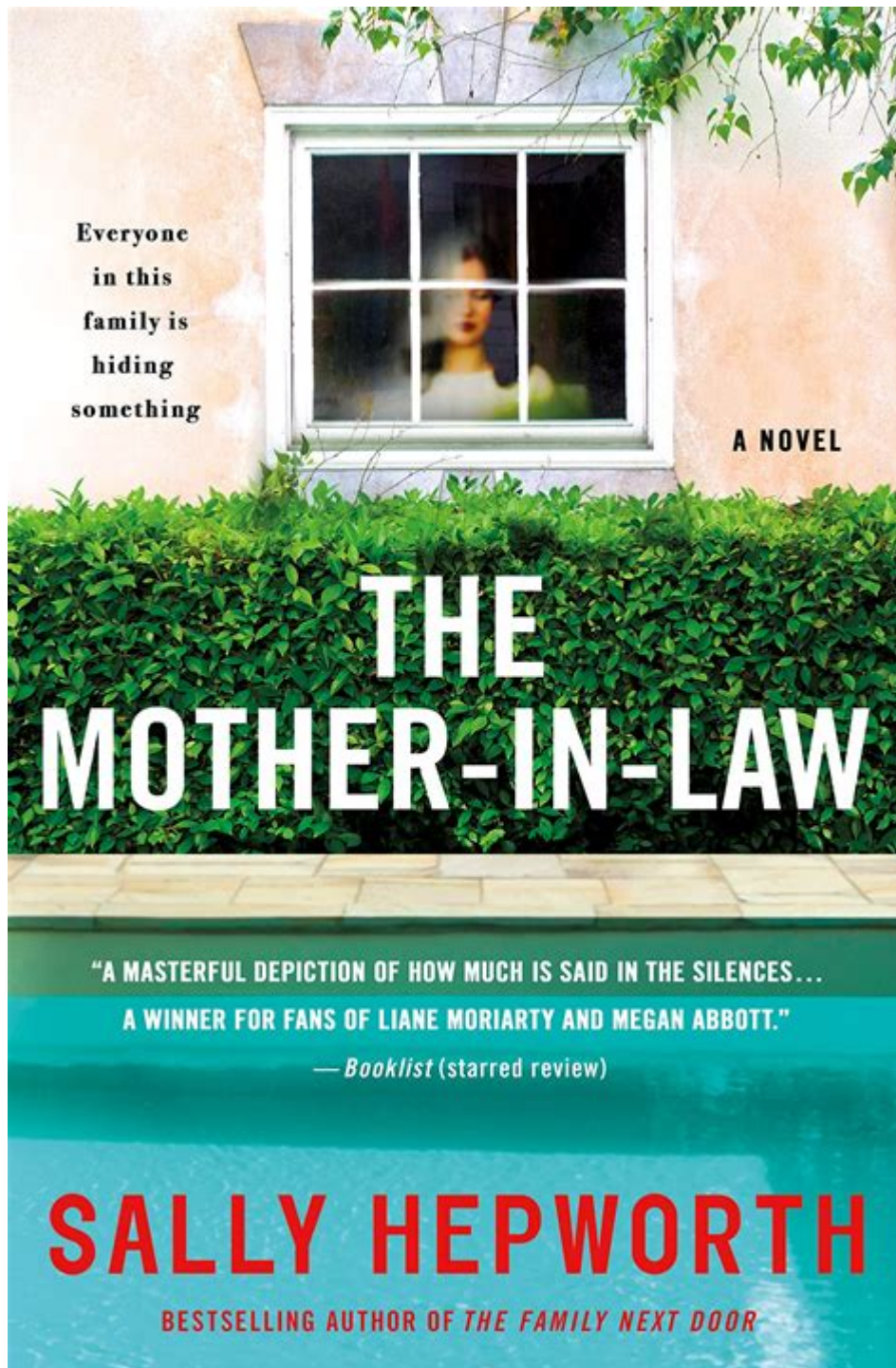


The Mother In Law Book
