- 1. If a man pokes out the eye of another man, his eye shall be poked out.
- 2. If he breaks another man's bone, his bone shall be broken
- 3. If a man knock out the teeth of his equal, his teeth shall be knocked out.
- If a builder builds a house and does not make the construction firm, and the house collapses and causes the death of the owner, that builder shall be put to death.
- 5. If a son strikes his father, his hands shall be cut off.
  - 6. If a doctor is makes a mistake in a surgery and the patient dies, the doctor's fingers shall be cut off.
