IMPLEMENTATION OF PROHIBITION

Prohibition was officially enacted with the passage of the 18th Amendment to the United States Constitution in 1919, along with the Volstead Act, which provided for the enforcement of Prohibition.

1. THE 18TH AMENDMENT

- RATIFIED ON JANUARY 16, 1919, THE 18TH AMENDMENT PROHIBITED THE MANUFACTURE, SALE, AND TRANSPORTATION OF INTOXICATING LIQUORS.

3. Public Discontent
