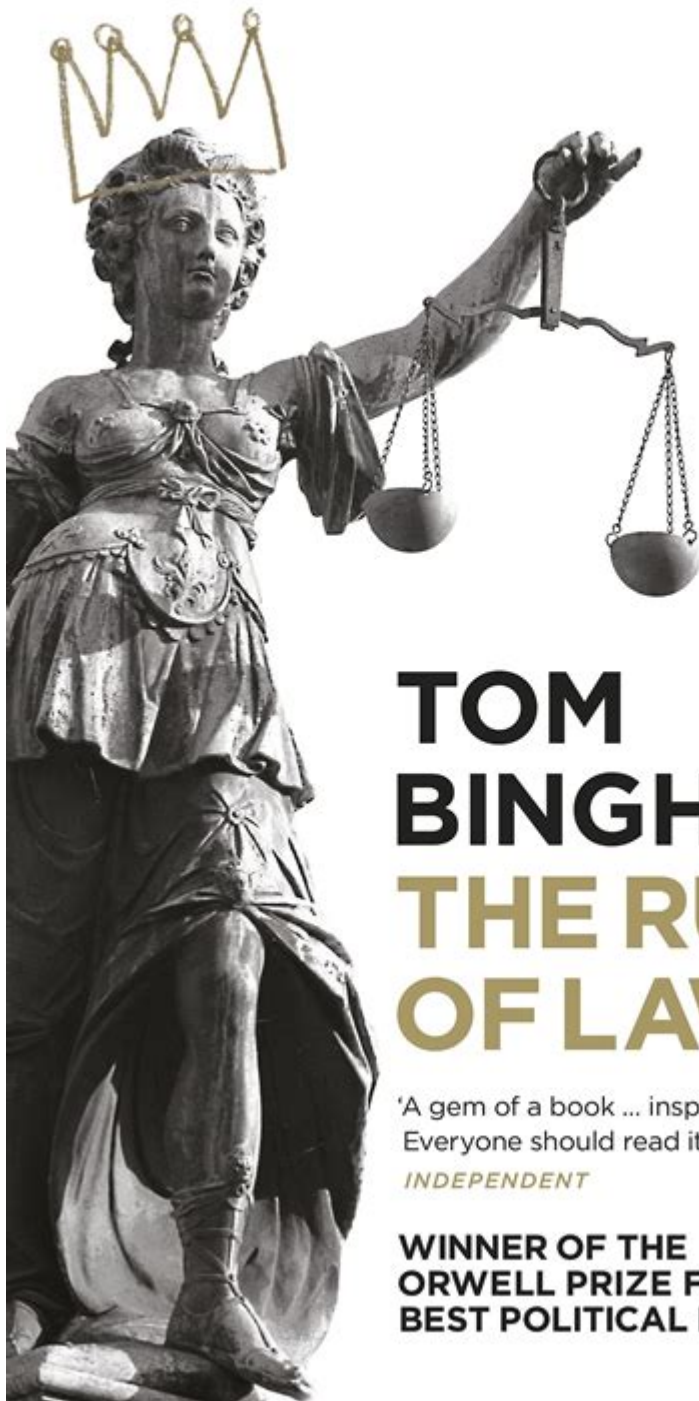

THE RULE OF LAW: TOM BINGHAM

TOM BINGHAM: A CHAMPION OF THE RULE OF LAW
