Setting up and connecting your card reader requires just a few steps.

 You should have already unpacked your card reader and activated your reader in the Chase Merchant Center. If not, visit <u>chase.com/MyPaymentsCenter</u> to complete your activation. Important: Your card reader should remain unplugged and powered off until you've completed activating your device in the Chase Merchant Center.

2. Connect Power cables

Connect the dongle cable ① to the back of the card reader and the power supply ② to the dongle cable and power source. See diagram below.

Note: The card reader will turn on automatically once it is plugged into a power source.
