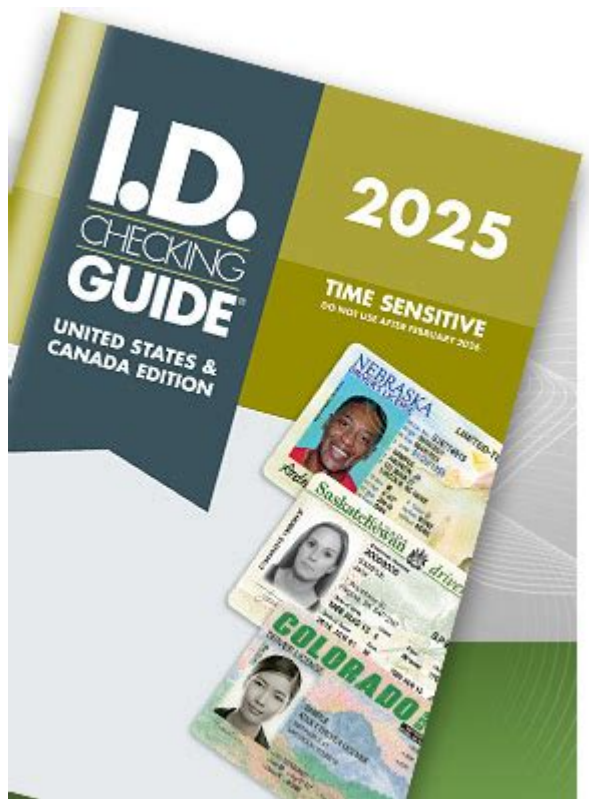


# Us Id Checking Guide
