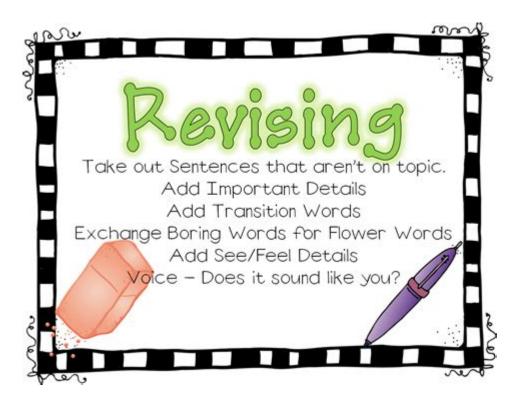
# What Is Revising In Writing Process

## STAGES OF THE REVISING PROCESS

THE REVISING PROCESS CAN BE BROKEN DOWN INTO SEVERAL KEY STAGES:

## 1. REVIEW YOUR DRAFT
