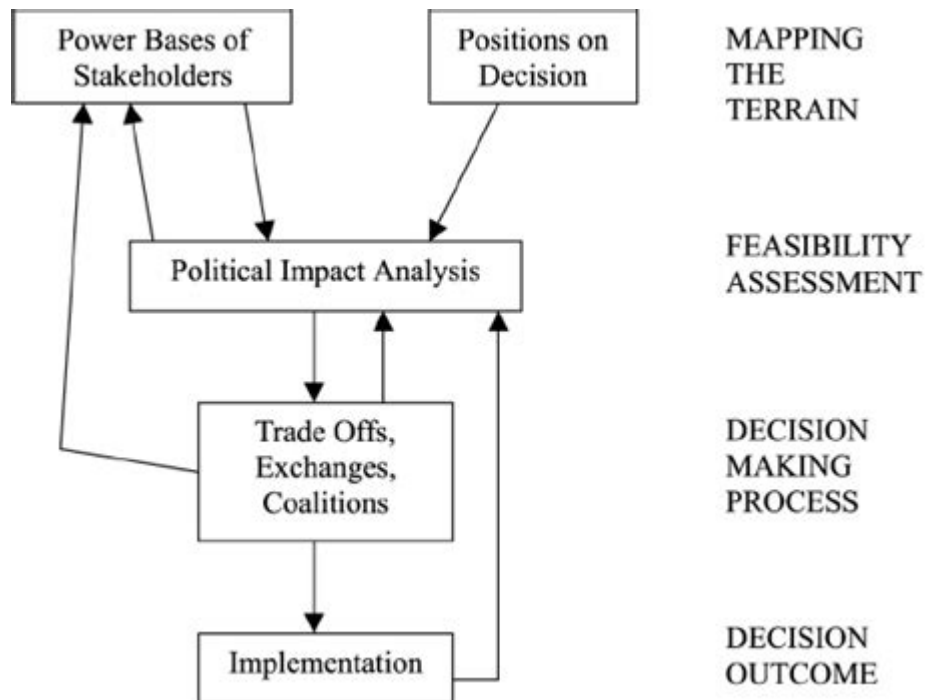


What Is Political Feasibility
