WHERE CAN I FIND MY RESIDENCE HISTORY? 1.3. PHOTO ALBUMS AND SOCIAL MEDIA

PICTURES OFTEN CAPTURE SIGNIFICANT LIFE EVENTS, INCLUDING HOUSEWARMING PARTIES OR MOVING DAYS. ADDITIONALLY, SOCIAL MEDIA POSTS CAN SOMETIMES PROVIDE CLUES ABOUT WHERE YOU LIVED AT SPECIFIC TIMES.

2. PUBLIC RECORDS

IF PERSONAL RECORDS DON'T PROVIDE SUFFICIENT INFORMATION, PUBLIC RECORDS CAN BE A VALUABLE RESOURCE FOR UNCOVERING YOUR RESIDENCE HISTORY.

2.1. COUNTY ASSESSOR'S OFFICE

- PROPERTY RECORDS: THE COUNTY ASSESSOR'S OFFICE MAINTAINS RECORDS OF PROPERTY OWNERSHIP. YOU CAN REQUEST INFORMATION REGARDING PROPERTIES YOU HAVE OWNED OR RENTED.
- TAX ASSESSMENT RECORDS: TAX RECORDS WILL SHOW THE OWNERSHIP HISTORY OF PROPERTIES, WHICH CAN HELP ESTABLISH YOUR RESIDENCE HISTORY.

2.2. LOCAL GOVERNMENT OFFICES

- CITY OR COUNTY CLERK'S OFFICE: THESE OFFICES OFTEN KEEP RECORDS OF ADDRESSES ASSOCIATED WITH VOTERS, MARRIAGE LICENSES, AND OTHER OFFICIAL DOCUMENTS.
- COURT RECORDS: IF YOU HAVE BEEN INVOLVED IN ANY LEGAL MATTERS, THE COURT RECORDS MAY PROVIDE YOUR LAST KNOWN ADDRESS.

2.3. ONLINE PUBLIC RECORDS DATABASES

MANY WEBSITES AGGREGATE PUBLIC RECORDS AND MAKE THEM ACCESSIBLE ONLINE. SOME POPULAR OPTIONS INCLUDE:

- ZILLOW: OFFERS PROPERTY HISTORY AND OWNERSHIP DETAILS.
- WHITEPAGES: ALLOWS YOU TO SEARCH FOR ADDRESSES ASSOCIATED WITH YOUR NAME.
- SPOKEO: A PEOPLE SEARCH SITE THAT PROVIDES ADDRESS HISTORY AS PART OF ITS REPORT.

3. ONLINE SEARCH TOOLS

THE INTERNET OFFERS A PLETHORA OF TOOLS AND RESOURCES TO HELP YOU TRACK DOWN YOUR RESIDENCE HISTORY.

3.3. BACKGROUND CHECK SERVICES

VARIOUS SERVICES PROVIDE COMPREHENSIVE BACKGROUND CHECKS THAT INCLUDE RESIDENCE HISTORY. EXAMPLES INCLUDE:

- BEENVERIFIED
- INTELIOUS
- TRUTHFINDER

KEEP IN MIND THAT THESE SERVICES USUALLY REQUIRE A FEE, BUT THEY CAN PROVIDE A THOROUGH AND DETAILED REPORT.

4. CONTACT PREVIOUS LANDLORDS OR PROPERTY MANAGERS

IF YOU ARE TRYING TO RECALL SPECIFIC RENTAL PROPERTIES, REACHING OUT TO PREVIOUS LANDLORDS CAN BE BENEFICIAL. HERE'S HOW TO GO ABOUT IT:

4.1. GATHER CONTACT INFORMATION

- LOOK FOR ANY LEASE AGREEMENTS OR COMMUNICATION THAT MIGHT CONTAIN THEIR CONTACT DETAILS.
- USE ONLINE RESOURCES LIKE LINKEDIN TO FIND PAST LANDLORDS OR PROPERTY MANAGERS.

4.2. PREPARE YOUR INQUIRY

WHEN YOU CONTACT THEM, BE PREPARED WITH NECESSARY INFORMATION SUCH AS:

- YOUR FULL NAME

IF YOU HAVE HELD A DRIVER'S LICENSE IN YOUR NAME, YOUR STATE'S DMV WILL HAVE RECORDS OF YOUR ADDRESSES.

6.1. REQUEST YOUR DRIVING RECORD

- VISIT THE DMV WEBSITE FOR YOUR STATE TO LEARN HOW TO REQUEST YOUR DRIVING RECORD.
- SOME STATES MAY CHARGE A SMALL FEE FOR THIS SERVICE.

6.2. VERIFY YOUR ADDRESS HISTORY

YOUR DRIVING RECORD WILL TYPICALLY INCLUDE A HISTORY OF ADDRESSES ASSOCIATED WITH YOUR LICENSE, PROVIDING FURTHER PROOF OF YOUR RESIDENCE HISTORY.
